LAST SECTION COMMITTEE ELECTIONS HELD:

Date: 02/06/2022

Venue: In 2022, Section Board Elections have been virtually performed on June 1-2, 2022 by email. The Section Board was confirmed also in the period 2022/2024 (UV as Section Chair, DE as Co-Chair, LO as Secretary, TG as Councilor for research in Digital Psychiatry). OEA was appointed as Councilor for networking in Digital Psychiatry and SK as Councilor for surveys in Digital Psychiatry.

ACTIVITIES OF THE SECTION IN 2023:

Meetings/events

Section Business Meeting

Description:

An in-person Section business meeting was organized on March 26th, 2023, during the 31st EPA Congress which was held in Paris from March 25th-28th, 2023. Minutes of the Section business meeting have been then disseminated by email to all members on April 15, 2023. The main points are summarized here:

- Section Chair (UV) welcomed attendees and listed apologies received by other Section members. UV read out the agenda, which was unanimously adopted.
- Section Chair (UV) mentioned the activities carried out by Section officers and members during the past year (listed in the 2022 EPA Section Annual Report which will has been attached and sent out by email together with the current minutes, to all section members) and those within the current 31st European Congress of Psychiatry (CME Course, Inter-Section Symposium, Workshop). 2022 EPA DP Annual Report





was approved unanimously by all EPA DP Section members.

- The Section Chair (UV) reminded attendees about requirements and deadlines for submission for the next 32nd European Congress of Psychiatry which will be held in Budapest, Hungary on 6-9 April, 2024 and encouraged all Section members to propose educational and/or scientific initiatives. Several proposals have been already received, including Digital Psychiatry-related activities in collaboration with the EPA ECPC which will be planned during 2023.
- Section Chair (UV) talked about the great interest of attendees who joined the EPA DP Section supported CME course on the digital tools and interventions applied in the field of the assessment and treatment of Hikikomori (Social Withdrawal) and proposed to submit it again as section supported course for the next 32nd EPA Congress. All attendees unanimously agreed.
- Section Chair (UV) communicated to all attendees that the project about the video toolkit on Telepsychiatry in collaboration with EPA Committee on Education has been completed and will be released and available for all EPA members through the EPA Education platform, after the 31st EPA Congress (already advertised through the EPA Congress App and newsletter) at the following link: https://elearning.europsy.net/enrol/synopsispaypal/index.php?id=10.
- Section Chair (UV) updated all attendees about the further developments and collaboration of the EPA Section on Digital Psychiatry within the task force on the digitalization of the World Psychiatry Association (WPA) and in the task force on digitalization of the European Psychiatry Association (EPA), to the aim for the section to actively contribute to define a roadmap for digitalization across all European countries.
- Section Chair (UV) talked also about the possibility to plan, within the activity "Help the helpers" by the Secretary for Sections Martina Rojnic, a webinar outside the EPA Congress about to increase the digital engagement.
- Other initiatives/ideas/proposals collected during the business meeting were on workshop/symposium proposals for the upcoming 32nd EPA Congress: a) a joint symposium with Cultural Psychiatry section (e.g., in the form of a case-based workshop on how to implement DP in times of emergencies/crisis such as war)(UV); b) a joint symposium/workshop about digital rehabilitative interventions (UV, KK); c) a joint symposium/workshop together with the Section on Addictive Disorders about Digital Technopaties and the role of the web/digital tools in the treatment of digital addictions (LO); d) a course or a workshop about implementation strategy/methodological strategies, limitations/barriers on carrying out research studies in the field of DP (by proposing also a possible involvement of ECPC)(TG, LO); e) a workshop on Serious Games by involving speakers from UCL (ideators of Brain Explorer app)(SK).
- Other initiatives/ideas/proposals collected during the business meeting were on designing research studies or collection of data coming from shared digital platforms/tools (SK), even though it was also discussed the difficulty in homogeneously collecting some data from section members with limited financial resources or without access to these tools. SK proposed a multicentric study whose design will be shared with all board members and then to section members about a short survey addressed to patients affected with severe mental illness (i.e., schizophrenia spectrum disorders, mood disorders, etc.) about smartphone ownership, smartphone usage (average daily screen time), attitude towards digital therapeutics, expected benefits, main concerns, and so forth.
- Section Chair (UV) communicated to all attendees that together with the ECPC, particularly the Task force on Communication and Publication chaired by EC have been organized an ECPC-supported online talk activity with UV as "expert" speaker, EC and LO as chairs of the session about Telepsychiatry and





Digital Psychiatry. The initiative was disseminated through the EPA website and through the ECPC and many ECPs joined the initiative and showed great enthusiasm on the topic. Moreover, several joint symposia together with the ECPC have been organized during the current 31st 2022 EPA Congress and further requests and collaborations will be implemented with ECPC. Furthermore, section Chair (UV) stimulated all attendees to involve more ECPCs as active members of the section also in research activities in this field.

- The secretary of the Section (LO) updated attendees with the latest figure of Section membership (reporting a further increase from 57 members in 2021 to 73 active members in 2022 to current 79 members up to date). The Section Chair (UV) discussed strategies to increase a more active participation of members at the EPA DP section (also research) activities and during the EPA Congress. SK and KK proposed to design some multicentric research studies, easy to be
